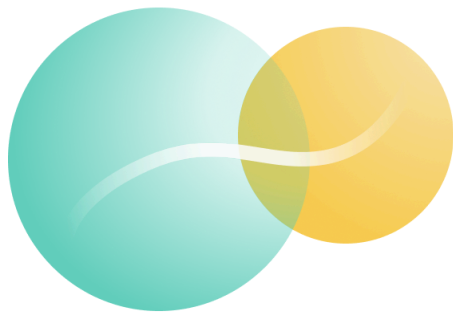

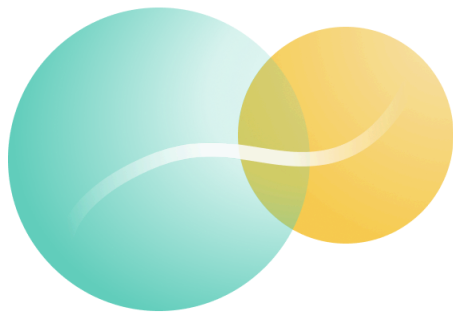

## Application Instructions

Please read Instructions carefully.

1. Name
  - a. The name of the Individual producer.
2. Pronoun
  - a. Pronoun of the Individual producer.
3. Age
  - a. Used for data collection purposes ONLY. Does not in any way affect your eligibility.
4. Ethnicity
  - a. Used for data collection purposes ONLY. Does not in any way affect your eligibility.
5. Anticipated Graduation Date
  - a. If you are currently a College/University student.
6. Date of Commencement
  - a. If you are an alumnus.
7. Artist Resume + Headshot
  - a. Résumé can be 2 pages max.
  - b. Headshot must be high quality and should not exceed 2 MB.

## 8. Proposed Project (**Minimum 250 words - Maximum 500 words**)

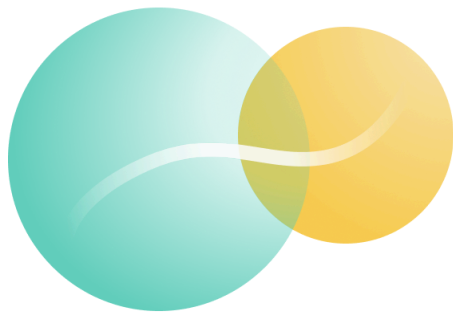
- a. Tell us about your proposed project. Must include answers for questions below in narrative (story) form.
  - i. Artist Statement
  - ii. What is your vision for this production? What form of dance are you looking to produce?
  - iii. How do you plan to use music, sound and/or silence? (Please note: if you are using music from established artists you will need to review the process of asking for musical rights).
  - iv. Describe your technical needs (e.g costumes, props, projection)
  - v. Who is your target audience?
  - vi. What is your marketing strategy (social media, flyers, word of mouth, etc.)?
  - vii. How will you generate additional funds for the production? (event, class, online donations, etc.)

## 9. Video of Self - What strengths do you currently possess that will help you excel in producing? Through this process, what areas do you wish to grow in? What are you hoping to learn/gain through the process?

- a. Submit a 2-minute video answering the prompts above on the application.
- b. Upload the video to Vimeo as a password protected file.
- c. Upload Vimeo link and provide password on application.

## 10. Video of Work

- a. **For Producer Only:** Please submit a 1-minute and 30-second video of work from the choreographer/collaborator you are hoping to work with.
- b. **For Producer & Choreographer:** Please submit a 1-minute and 30-second video of your past work or work you are looking to expand upon for the production. If the video is longer than 1-minute and 30 seconds, please specify time stamps for the segment you would like us to watch.
- c. Note that we will not watch past 1 minute and 30 seconds, so please make the time captured great!
- d. The video can be a rehearsal clip, previous performance, or dance reel.
- e. Upload the video to Vimeo as a password protected file.
- f. Upload Vimeo link and provide password on application.

## 11. Projected Budget

- a. A budget template is provided for you to use, but you are welcome to use another as long as it states the correct information.
- b. The projected budget should not have receipts, as it should cover items you wish to purchase.

## 12. Projected Timeline

- a. Examples of what the timeline will entail are audition date, rehearsal dates, deadline to find a venue, tech dates, show dates, etc. The applicant is not limited to these examples.

### Application Timeline

- **October 6, 2025:** Application opens
- **November 21, 2025:** Application closes at 11:59 PM EST. All materials must be submitted by this time. Any applications submitted after 11:59 PM EST will not be reviewed.
- **November 24, 2025 - December 12, 2025:** Panel reviews and selects a recipient.
- **December 19, 2025:** Recipient notified via email.
- **December 22, 2025 - December 30, 2025:** Recipient submits paperwork.
- **Before or By January 30, 2026:** Recipient will receive a check from FJC
- **January 2026 - June 2026:** Production Planning Period
- **Coaching Meetings:** February 2026, April 2026, and May 2026 (exact dates TBD)
- **June 2026:** Presenting Production
- **July 2026:** Submit Final Report + Debrief Meeting
